This survey focuses on 5 key issues for the Acadian and Francophone community in Nova Scotia:

- Early Childhood
- Francophone Immigration
- Support for Francophone Organizations in OLMCs (Official Language Minority Communities OLMC)
- Federal Support to Provinces in Providing Access to Quality French-Language Services
- The Judicial Contestation Program

#### **EARLY CHILDHOOD**

In Nova Scotia, there are **only 380 spots available** in French-language daycares. Meanwhile the **current demand requires 3,780 spots**.

Access to education and training to guarantee qualified personnel to work in early childhood education and care is extremely important. French-language colleges and universities need financial support to offer this training.

#### **Questions:**

- 1. Given the lack of available spots in French-language daycares, what do you propose to improve access to French-language childcare services for Francophone families?
- 2. Will your party support and fund French-language colleges and universities in minority communities to offer training programs for early childhood education and care for Francophone children?

## FRANCOPHONE IMMIGRATION

The Official Languages Act requires that **the demographic weight** of minority Francophones communities throughout the country (Official Language Minority Communities – OLMC) be **restored to what it was in 1971**.

In Nova Scotia, the demographic weight was 5%. Today it is 2.9%.

## **Questions:**

- 1. What do you plan to reverse the declining trend in the demographic weight of Francophones in Nova Scotia (currently 2.9% compared to 5% in 1971)?
- 2. How do you plan to encourage Francophone immigration to Nova Scotia, to support the growth of the French community and help meet the demand for French-language services in the province?

#### SUPPORT FOR FRANCOPHONE ORGANIZATIONS IN MINORITY COMMUNITIES

The Fédération acadienne de la Nouvelle-Écosse (FANE) and its 29 member organizations work hard to preserve the French language and culture.

The **continuation of this work** is ensured through **financial support** from the federal government.

#### Question:

1. How do you plan to financially support Francophone organizations in minority communities, such as FANE, so they can continue their important work?

## FEDERAL SUPPORT TO PROVINCES: ACCESS TO QUALITY FRENCH-LANGUAGE SERVICES

**Provinces** like Nova Scotia **rely on federal support** to provide **French-language services** to its citizens. The Nova Scotia government passed the **French-Language Services Act** in 2004 and revised it in 2024. **To implement this law**, federal **financial support is necessary**.

#### Question:

1. How should the federal government aid the province to offer French-language services in a more efficient and accessible manner to its Francophone citizens?

## JUDICIAL CONTESTATION PROGRAM

The Judicial Contestation Program is very important for Francophone minority communities. **This program helped**Acadians and Francophones in NS **obtain French-language schools**. Additionally, this program allowed the Chéticamp region to gain the right to a provincial protected special electoral district.

### Question:

1. The Judicial Contestation Program has played a key role in obtaining rights for Francophone communities. Do you support maintaining and strengthening this program to uphold the rights of Francophones in minority situations?
